Thanksgiving Holiday Around The Corner

In observance of Thanksgiving, employees are reminded that Thursday, November 24 and Friday, November 25 are Data General paid holidays.

Due to the holidays, time cards for the week ending November 19 are due in Payroll at 3 p.m. on Thursday, November 17. Any unscheduled overtime should be included in the next time card.

Time cards for the week ending November 26 should be picked up at Payroll on Tuesday, November 22 at 3 p.m. and will be due back by 3 p.m. on Wednesday, November 23.

Pay checks will be available for pick-up at 10:30 a.m. on Wednesday November 23.

PBX Interfaces With Three Vendors

Data General has signed agreements with three Private Branch Exchange (PBX) vendors enabling Comprehensive Electronic Office (CEO) workstations and DESKTOP GENERATION computers to connect to ECLIPSE MV/Family systems using PBXs.

The PBXs whose interfaces have been certified with ECLIPSE MV/Family systems are: InteCom Inc.'s IBX Family, ROLM's CBX Family and United Technologies Lexar UTX-1001. Interface support for Northern Telecom Inc.'s SL-1 PBX is currently being provided as part of an agreement announced earlier this year. A PBX is an internal telephone system serving several locations and connects to a public telephone exchange. Computer users can tie terminals into a CPU through existing phone cables. This reduces expenses, delays and the inconveniences involved with installing cables for transmitting data.

Integrated PBX/CEO office systems give users a low-cost method for connecting terminals and workstations to host computers, as well as integrated voice and data facilities.

Traditionally, PBX users are large corporations, government agencies, banks, hospitals, hotels and universities. Currently, there is an increasing demand from smaller users for the functionality and cost reductions a PBX system can bring to a company's communication system.

Understanding Stock Splits

On November 18, Data General's common stock will split two-for-one.

Why is the stock being split?

Data General decided to split its common stock to make it more affordable to more people, which will broaden the ownership of the stock and the company. Data General also has a low number of shares outstanding when compared to its high-tech competitors.

How does the stock become more affordable?

First: The per-share price will be lower. It is more affordable to buy 100 shares at \$35 each (\$3500 total) than it is to buy 100 shares at \$70 (\$7000). The lower price will enable people with a limited amount to invest to buy more shares for the same dollars.

Second: Stockbrokers who charge commissions for handling your stock transactions often charge less if you buy your stock in 100-share lots than in odd lots (less than 100 shares or between 100-200 shares). You will be able to buy a larger amount of shares at a lower price and save on commission charges.

How does the stock split affect the Employee Stock Purchase Plan?

Before the stock split, 85 percent of the opening day (August 1, 1983) price was \$56.50. Due to the

split, it now will be calculated at half that amount, or \$28.25. If you are having \$10 per week deducted from your pay, you will have a total of \$260 available to purchase stock when the current 26-week purchase period ends. Divide your \$260 by the option price (\$28.25 or 85 percent of the closing date price, whichever is lower) to determine the number of shares you can purchase. You will be able to buy more shares at a lower price per share than if the stock had not split.

How does the stock split affect stock options?

If you have stock options with Data General, the total value remains unchanged. Example: Before the split you had an option to buy 100 shares at \$25 per share, for a total cost of \$2500. After the split, your option will cover 200 shares at \$12.50 per share, which is still a total cost of \$2500.

What does the stock split mean to a shareholder?

First: Stockholders of record as of November 7 will own double the number of shares of stock they owned the day before.

Second: Each share will have approximately half the worth of the day before.

Third: The overall value of the stock will remain approximately the same.

Will you make or lose money when the stock splits?

The split itself does not change the value of your holdings, but the market will set a post-split price that could be higher or lower than half the pre-split price.

Will the stock price rise rapidly after the split?

There is no long-term evidence to support the theory that a stock price rises more rapidly after a stock split than before it.

Employees May Receive Several Stock Certificates

The two-for-one stock split of Data General stock, payable on November 18, may bring many employees several stock certificates. There's a good reason for this.

Employees purchase stock under the Employee Stock Purchase Plan and certain stock option plans at different times and there are different "holding periods." The holding period for the additional shares resulting from the stock distribution is the same as the holding period for the original shares.

All holders of record of Data General stock on November 7, 1983 should receive their stock dividend on November 18.

Stockholders Should Update Addresses When They Move

Even though you are a Data General employee, there is not an automatic change in address on your Data General stock when you move.

If you are a Data General stockholder, be sure to change your address with the company's stock transfer agent when you move. This is in addition to changing your address at Data General through your supervisor.

This simple address change procedure will assure you get all stockholder mailings from the company such as quarterly and annual reports, the annual meeting notice and annual meeting proxy for voting your shares. The 1983 annual report, annual meeting notice and proxy will be mailed early in December.

For your convenience, the following form is printed. If you do not use the form, be sure all information indicated on the form is included in your letter. Mail it to Morgan Guaranty Trust.

If you have Data General stock being held by a broker, you might consider transferring it into your name so that company information will be received by you on a more timely basis.

A few suggestions to keep your stock account as uncomplicated as possible:

1. Always use the same form of your name when purchasing stock.
2. If you always have the same form of joint owner, use the same form of that person's name as well.
3. Notify the stock transfer agent whenever you move.
4. If you have stock with different joint owners or in different forms of your name, make sure you change the address for all combinations whenever you move.
5. Vote your stock. Even when proposals appear to be routine, you should exercise your right to vote. Failure to vote is not counted as supporting or rejecting proposals.

"Miracle Workers" Circle Project Wins Approval

The "Miracle Workers" PRIDE Circle, comprised of employees from the Engineering Change Order (ECO) Assembly area on first shift, has received approval for its proposal to improve ECO documentation. The proposal was made during the Circle's first presentation to the PRIDE Circle Steering Committee.

Circle Leader Pamela Appell began by giving an introduction on the history of the Circle, citing some of the projects it previously had implemented: decreasing noise in the area; taking part in choosing tools; and recommending having one turntable distribute parts to four people rather than two, which created more space in the area.

The major project undertaken by the Miracle Workers has been to organize and repackage the extensive ECO files in Assembly. All members of the Circle took part in the presentation on this project.

The research the group had done pointed out that assemblers were spending many hours handling tasks such as organizing and preparing the ECO files. Using PRIDE Circle techniques and with further analysis, the Circle was able to demonstrate that it would be less costly in the long run to dedicate one person as a clerk to handle the ECO filing system maintenance and scheduling of ECOs.

Through cause-effect diagramming, the Circle members noted that there was no sign-in/sign-out system for the files and the instructions that were available were poorly written. The Circle designed a sign-in/sign-out form for the ECOs, and rewrote the instructions on filing ECOs.

Due to a large percentage of employees primarily speaking Portuguese, Circle member Virginia Benevides translated the filing instructions into that language.

Circle members said the addition of an ECO filing clerk would increase productivity because the ECOs would be maintained regularly and updated more often. Time would be saved because assemblers would not be wasting time searching for an ECO. Since the ECOs would not need replacing as often, the department would save money.

The Steering Committee was impressed with the presentation of the ECO documentation problems and with the thoroughness and professionalism of the Circle's recommended solution.

"The hard work in performing a statistical analysis and work study was evident in the execution of a smooth, flowing presentation. I am very pleased by the Circle members' efforts in making this such a professional, well-planned presentation," says Operations Manager Ed White.

Within two weeks, the Steering Committee responded favorably to the Miracle Workers proposal, and already has approved the Personnel requisition to hire a material coordinator. The Miracle Workers are thrilled to receive this approval and are enthusiastic about undertaking their next project.

Benefits

Social Security Law To Affect Savings And Investment Program

Recent Congressional action to reform the Social Security System will affect active participants of the Data General Savings and Investment Program next year. Effective January 1, 1984, your contributions to the program will no longer be exempt from Social Security (FICA) tax. Currently, FICA tax is applied only to the wages remaining after your savings plan contribution has been deducted.

There has been no change in the pre-income tax nature of the contributions. Contributions to the program will be deducted from your pay after the FICA tax but before the federal income tax and, in most cases, state income tax is withheld.

Prior to this reform, your final Social Security benefit may have been slightly less due to reducing your income subject to FICA tax. (The amount of income subject to FICA tax is the basis for your final benefit.) Active participants will not receive a reduced Social Security benefit when they retire since FICA tax will be applied to all earnings up to the maximum FICA wage base.

The Social Security Administration will announce the 1984 maximum FICA wage base later this year. It is expected to be somewhat higher than the current maximum of \$35,700.

Savings & Investment Program Questions Answered

The quarterly statements for the Savings & Investment Program were recently distributed to plan participants. Some of the typical questions asked by participants about the Balanced and Equity Funds are shown below with the answers. If you have other questions about your statement, contact your local Benefits administrator or Barbara Wahl in Corporate Benefits at Westboro ext. 4524.

What do the earnings on my statement mean?

The earnings shown on your quarterly statement for the Equity and Balanced Funds represent the amount of appreciation or depreciation of the Funds during the three month period covered by that statement. The "earnings" measure the increase (or decrease) of the value of your account based on the "per share" price as of the last day of the quarter.

The closing balance reflects only the value of your account as of September 30. This value will continue to change as the market fluctuates each day.

In general, how are the Funds doing?

The Equity Fund is down for this quarter; the Balanced Fund is up slightly. However, since stocks are expected to fluctuate, you may also want to look at the performance of the Funds over a longer term than the three months covered by this quarterly statement.

The Equity Fund, for example, went up 14.3% during the nine month period from January through September, 1983. The Dow Jones Industrial Average (DJIA) increased 22% in the same period. Over the three year period ending December 31, 1982, the Equity Fund increased 76% while the DJIA increased 49.7%. Over the ten year period ending December 31, 1982, the Equity Fund gain was 117.3% and the DJIA gain was 74.8%.

A similar pattern shows in the results for the Balanced Fund with an increase of 15.4% for the nine month period from January through September, 1983, 69.3% for the three years ending on December 31, 1982, and 111.7% for the ten years ending on that same date.

The statement lists everything in dollars. I thought I was buying shares in a mutual fund. Shouldn't the number of shares be listed?

While the plan's investment is in shares of the fund, your part of the plan is in dollars. The portion of your total contribution that you allocate to a particular fund -- the Balanced Fund, for example -- is pooled with the portions that other participants in the plan are directing to that same Fund. That amount is then used to purchase shares of the mutual fund, which are owned by the plan and held in a single account. The value of your account that is shown on your quarterly statement is determined by how much you contributed to the Fund(s) and your share of the

Fund's investment performance.

How do I keep track of my investment?

The quarterly statement you just received is designed to do that. Your investments in the Equity or Balanced Funds change every day with stock market movements. However, since the Savings & Investment Program is intended as a long term, continuous program, and not a short term, trading program, a statement is produced only once every three months.

If you would like to track your own investment more frequently, please refer to the last newsletter for the detailed formula to estimate your up to date account balance.
