### Get Your Time Cards In

Due to the upcoming Data General-paid holidays (December 25 and 26, and January 1 and 2), employees in Westboro and Milford should note the following time card schedule.

All time cards for the week ending December 20 will be distributed on December 17 at 10:30 a.m. and are due back into Payroll by 3:00 p.m. that same day.

Time cards for the week ending December 27 will be distributed on December 22 at 10:30 a.m. and are due back into Payroll at 3:00 p.m. that same day. Pay checks for the Christmas week will be handed out on December 24 at 10:30 a.m.

Time cards for the week ending January 3 will be distributed on December 30 at 10:30 a.m. and are due into Payroll by 3:00 p.m. that same day. Pay checks for this week will be distributed to employees on December 31 at 10:30 a.m.

## ECLIPSE MV / 15000 Establishes Leadership In Price / Performance

Data General has introduced the ECLIPSE MV/15000 series of mid-range, general-purpose 32-bit computers. The members of the ECLIPSE MV/15000 family are the Model 8, Model 10 and Model 20. The new systems are characterized by their industry-leading price/performance, cost of ownership features and powerful performance-upgrade capability.

Each processor, along with memory, is housed in a 10-1/2-inch-high chassis, which is mounted in a meter-high cabinet. Up to two expansion chassis and associated cabinetry can be configured with the host chassis.

The series was developed within the Systems Development Division in Westboro. It will be manufactured in Southboro.

### Features

The ECLIPSE MV/15000 series use a single printed circuit board (PCB) implementation of the ECLIPSE MV/Family architecture, making it compatible with the Data General product line.

Compared to competitive offerings and similar configurations from both Digital Equipment Corporation (DEC) and IBM, the ECLIPSE MV/15000 series has:

- A 33 percent to 60 percent price/performance advantage;
- Supports 25 percent to 100 percent more office automation users; and
- Is up to 62 percent faster in performing technical computations.

### Board Swapping

The ECLIPSE MV/15000 series allows users to upgrade their systems simply by swapping PCBs.

Memory for all of the ECLIPSE MV/15000 models is organized on modular PCBs, available in four MB, eight MB, 16 MB and 32 MB increments. Data General also is reducing prices on these PCBs for both the ECLIPSE MV/15000 series and the ECLIPSE MV/20000 computer systems from 45 to 50 percent.

The ECLIPSE MV/15000 Model 8 computer supports up to 60 active office automation users. The Model 10 system supports up to 100 office automation users, and the Model 20 computer supports up to 160 office automation users.

"We have brought state-of-the-art supermini processor technology down to the mid-range of our product line," explains Bob Miller, senior vice president of the Information Systems Group. "This ability to most effectively implement the latest technology also has provided this new series with price/performance leadership for new customers demanding the highest processing power available in a smaller mid-range size."

A hardware floating point processor for handling computation-intensive workloads is standard with the Model 20, and is offered as an option for the Models 8 and 10.

## **Software Support**

The ECLIPSE MV/15000 family operates under the AOS/VS operating system and can run a wide range of application software for business automation, distributed data processing, real-time processing, general technical computing, communications and network serving capabilities.

The new series also supports CEO comprehensive electronic office and and TEO technical electronic office software. In addition, the AOS/DVS, DG/UX, and AOS/RT32 operating systems will be supported in the future.

"The ECLIPSE MV/15000 series signals the completion of our third-generation of technology and represents a very strong leadership edge when viewed against competitive offerings from DEC and IBM," says Dave Lyons, vice president of Group Marketing.

The ECLIPSE MV/15000 series computers are available for immediate shipment. Upgrades for present ECLIPSE MV/4000, ECLIPSE MV/7800, ECLIPSE MV/8000 II and ECLIPSE MV/10000 customers to ECLIPSE MV/15000 models also are available immediately.

## **New MV Models Already A Hit**

Although just introduced, Data General's new ECLIPSE MV/15000 series of computers already is impressing customers across the U.S. Texaco, American Medical International, World Computer and HBO & Company are currently running applications on all three models of the ECLIPSE MV/15000 family.

### **Texaco**

Texaco already uses Data General equipment on a worldwide basis for process control applications, information systems and office automation. Texaco has been testing an ECLIPSE MV/15000 Model 10 and Model 20 with these applications along with application development.

"We switched from an ECLIPSE MV/10000 to the ECLIPSE MV/15000 Model 10 virtually without our programmers or users noticing," says Leland Chvatal, manager of distributed processing for Texaco's computer information systems department. "Two weeks later we simply changed the CPU to upgrade the Model 10 to the ECLIPSE MV/15000 Model 20 -- a procedure that was accomplished in approximately one hour. Using various performance benchmarks we have developed in-house, we measured about a 50 percent improvement in performance capability of the Model 20 compared to the Model 10."

## **AMI**

American Medical International (AMI) is a leading international healthcare service company. The company's Professional Hospital Services (PHS) division, Data General Authorized System Distributor, is the information processing subsidiary of AMI and provides a full range of financial, administrative, prospective payment, as well as patient care systems and services for hospitals ranging in size from 75 to 2000 beds. PHS has installed more than 200 systems in client facilities in the U.S. The PHS systems can be run on the entire range of ECLIPSE MV/Family processors including the new ECLIPSE MV/15000 models.

"AMI has been testing the ECLIPSE MV/15000 family and has been especially pleased with these systems ease of installation, low cost of ownership, compact size and the fact that the CPU can be upgraded by simply changing one board," says Dennis Peck, PHS senior vice president.

"Single-board upgradeability is particularly important to healthcare users as they are constantly adding new applications. In the past, clients faced costly system changes since the CPU, the most expensive component, had to be replaced when new user demands or applications changed the system priorities and size."

### **World Computer**

World Computer, headquartered in Michigan, is an original equipment manufacturer (OEM) that has been selling Data General systems since 1973. The company markets complete hardware and software packages to the financial institution industry that perform functions ranging from the simplest teller transaction to period-ending financial statements.

"We have been very impressed with the speed and power of these new machines," notes David Selina, senior vice president of marketing. "We received a Model 8, plugged it in, and were able to run our software immediately with no modification -- and upgrading the hardware to a Model 10 took less than ten minutes.

"While the ECLIPSE MV/15000 series is a viable upgrade for our existing customers, the fact that these machines can grow so easily with a customer's needs makes it an excellent, cost-effective, choice for our new prospects as well."

### **HBO & Company**

HBO and Company is one of the largest providers of hospital information systems in the U.S. and is a Data General value-added reseller (VAR). The company markets two Data General-based systems -- MEDSTAR, a patient inter-departmental information processing system that includes order entry and charge collection services, and CLINSTAR, a laboratory, pharmacy and radiology automation system which provides separate departmental support. Both are modular systems developed using the HBO fourth-generation STARBASE operating system. The company has been testing all

three models of the ECLIPSE MV/15000 family for use in both MEDSTAR and CLINSTAR packages.

"The improved reliability and ease of upgrading the new ECLIPSE MV/15000 models is very important to our marketplace," notes Peter van der Grinten, vice president of clinical products. "Being able to migrate to more powerful machines with minimum upgrade cost and minimum downtime is crucial to hospitals. The ECLIPSE MV/15000 series will enable hospitals to grow the size of their applications without having to make a major investment in new hardware or new software."

Bill received his bachelor's degree from Yale University and juris doctorate degree from the University of Pennsylvania.

As assistant general counsel for litigation, Morris oversees litigation matters which Data General may be involved in.

He has been with Data General for nearly 10 years, most recently as group counsel. Prior to joining Data General, Morris was with the firm of Emerson-Swan, and before that, Honeywell. He holds a bachelor's degree from the University of Notre Dame and juris doctorate degree from the same school.

## Company Report Lauded By Magazine

Corporate Communications Manager Ray Thomas of Public Affairs and External Reporting Manager Henry Wilson of Corporate Accounting recently were recognized for their work on the 1985 annual report from Financial World magazine in its 46th Annual Report Awards.

The company's report received third-place honors in the computer hardware category. Floating Point Systems received top honors, followed by Intergraph Corp. Judging of the nearly 1,000 entries was done by more than 60 investment analysts. Entries were judged for their usefulness to shareholders, prospective investors and investment professionals, as well as their graphic arts elements.

According to Robert Radsch, president of the New York Society of Securities Analysts and a member of the Board of Judges, annual reports must not just discuss the past year, but must "look to the future and enumerate goals."

## Occupational Nurses Bring Health To Heart

You and your health was the focus of a recent meeting of the company's occupational nurses from plants and offices located across the U.S.

The meeting, held late last month, marked the second time this year that Data General's health practitioners got together to "discuss issues to help us to keep abreast of recent developments within the scope of occupational health," says R.N. Nancy Powers of

Westboro's Health Services department. For instance, during the two-day seminar nurses listened to presentations on recent updates to the Occupational Health and Safety Act (OSHA), and discussed dietary needs with a representative of the New England Dairy and Food Council.

According to Nancy, the biannually-scheduled meetings also provide nurses with opportunities to discuss their operating procedures so that Data General's health-care practices remain efficient and effective. "They help to ensure that the health services areas at each facility conduct programs which are consistent with those at other Data General locations. In this way, the company can be assured that employees are receiving top-notch medical attention."

"One of the most widely-discussed issues at this past meeting centered around Data General's Employee Assistance efforts," says R.N. Nancy Notarangelo of Westboro. "Through the Employee Assistance efforts, nurses at plants and offices are able to provide confidential support to employees and their families. Through their own expertise, or local resources, nurses can direct employees to local agencies which can help them to resolve any problems they may have which deal with chemical dependencies, stress, family/marital issues, eating disorders and any other illnesses or family concerns."

At all Data General facilities, employees are urged to utilize the services provided, says Nancy Notarangelo. "The occupational health nurses at each facility are knowledgeable of the resources and organizations which may be able to provide employees with the best-available professional care."

## More Tax Information In the Mail

A second report on tax reform for Data General employees will be mailed to employees' homes during the next few days. Its focus is on tax withholding which can result in changes in take-home pay with the new tax rates in 1987. After reading the report, employees may wish to complete the IRS W-4 Tax Withholding form enclosed with the report to assure that federal tax withheld comes close to actual tax liability.

1987 will be a "bridge" between the old tax system and the new one. While most people will eventually pay no more than 28 percent federal income tax, the new system does not become fully effective until 1988. In 1987, most of the new rules take effect but the tax rates will range up to 38.5 percent.

Even if an individual's total income next year is the same as in 1986, taxes may change substantially based on the new law and personal situations. For example, each exemption - individual, spouse and children - will reduce taxable income by \$1900 next year, compared to only \$1080 this year. On the other hand, deductions for two-earner couples and sales taxes have been eliminated and deductions for consumer interest and IRA contributions have been curtailed.

In the past, a penalty has been assessed if a taxpayer's withholding was more than 20 percent below the final tax liability. Beginning in 1987, the penalty will be assessed if withholding falls short of tax liability by more than 10 percent. Additionally, all taxpayers are required to complete a new W-4 tax withholding form for their employers before October 1, 1987.

If you complete a new W-4 form, you will probably come close to your actual tax and need not worry about any penalty.

## Benefits

### Auto/Homeowners Premium Deduction Schedule

Employees enrolled in the auto/homeowners personal insurance program will not have insurance premiums deducted from their paychecks on December 24 or on December 31. The last deduction for the 1986 coverage year will be made from paychecks received on December 11 for bi-weekly paid employees, and on December 18 for employees who are paid weekly.

Deductions for the 1987 coverage year will begin on January 8 and will end on December 31.

## Watch Those Decorations

This holiday season, employees decorating their offices are asked to observe the following guidelines:

1. No live trees are to be used at any Data General location. Trees must be artificial and labeled fire-resistant.
2. All decorations also must be fire-resistant.
3. Tree lights are not recommended; however, if used, they must be Underwriters Laboratory approved. Contact the Facilities department for safety fuses and installation guidelines.
4. No decorations may be strung on electrical fixtures such as power poles, electrical bus bars or electrical cabinets because a shock hazard could result.
5. Decorations must be adequately secured and arranged so they do not hinder operations.
6. All decorations must be removed by Monday, January 5.

## Keep A Lid On Information

In order to remain a leader in this highly-competitive industry, Data General must continually invest in new and enhanced products. Employees from all areas of the company such as new product development, Manufacturing, Marketing, Sales and the various administrative support groups which handle sensitive information on a daily basis that is critical to the success of the business. That is why the company holds proprietary information as one of its most valuable assets.

The competitive advantages which Data General has attained are directly attributable to a variety of factors. Among these factors is employees' abilities to keep Data General proprietary information secure, and keep proprietary information of other companies outside the "company family" of Data General.

All Data General sensitive and proprietary information is not to be disclosed to any Data General employees who have no need to know of it. Likewise, company confidential information should not be disclosed to any people outside of the company, unless and only unless, a prior non-disclosure agreement has been approved by both managers and the Legal department and signed by the intended recipient.

In addition to keep "a lid on Data General proprietary information," employees should not receive any confidential information of outside companies. Sensitive information offered by representatives of outside companies should be refused as a matter of company policy,

and those employees from outside companies offering information should be referred to the Legal department.

What is Data General proprietary information? Data General proprietary information can be defined as any technical, business or other Data General information of material that the company considers sensitive, secret, competitive or private, which, if in the hands of a competitor, could weaken Data General's competitive position. A few examples are: costs and methods of manufacturing, pricing policies, business forecasts, employee lists, customer lists, patent applications, unannounced products, and present and future business plans.

Unsecured proprietary information in unlocked offices; data left on cubicle desks rather than in locked files; research data left on blackboards exposed to ground-level windows; failure to ensure frequent and regular password changes for access to computerized information; and failure to immediately deny computer access to those who have terminated or transferred are matters of real concern to all employees.

Remember, as spelled out in the Employee Agreement which employees signed when they started working at Data General, employees should keep all company proprietary information to themselves.

## New Helicopter Schedule Goes Into Effect

A new schedule for helicopter service between Data General's New England sites goes into effect on Monday, January 5. The times are listed below.

To make reservations call Corporate Travel in Westboro at extension 232-HELI (232-4354). Passengers must be at the helipad five minutes before scheduled departure time for loading and a safety briefing. Unless delayed by weather, flights will depart precisely on time.

Passengers who wish to depart/arrive at Southboro may do so by advising the reservationist. Actual departure time may be a few minutes before or after the scheduled time shown for Westboro/Southboro stops.

Mail and packages destined for New England sites may be left in the mailbox at each helipad for delivery. Senders should check with Corporate Travel to ensure that the scheduled flight is going. It is the sender's

responsibility to arrange for pick-up at the destination. The pilot will deliver the material to the appropriate mailbox, but they are not serviced by the mailrooms. Any package weighing more than five pounds must be pre-arranged for delivery with Corporate Travel.
