

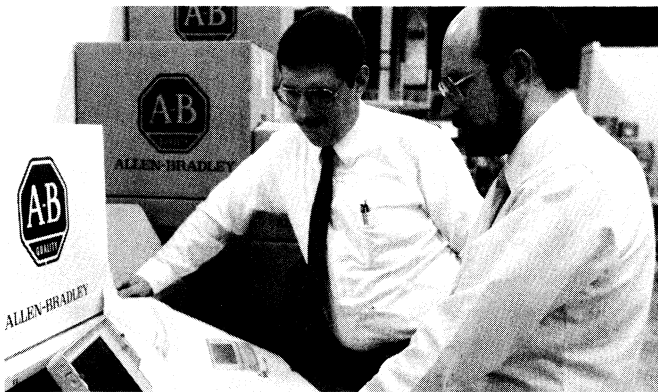

### Data General, Allen-Bradley Sign Four-Year Contract

Data General has entered into an agreement with the Allen-Bradley Company for DATA GENERAL/One Model 2T portable computers that could approach \$20 million over a four-year period. The contract will result in a new Allen-Bradley programming terminal product, the 1784-T45 portable terminal, based on the portable computer. First shipments have been completed.

"Data General will produce a 'private branded' version of the DATA GENERAL/One Model 2T to be used as a programming terminal for Allen-Bradley programmable logic controllers," says Terry Bennett, director of Manufacturing Industries Marketing at Data General. "The T45 will contain special interface boards developed and manufactured by Allen-Bradley, and it will bear the Allen-Bradley name and logo."

Allen-Bradley is designing special boards for the DATA GENERAL/One Model 2T computer to work in conjunction with Allen-Bradley's PLC-2, PLC-3 and PLC-5 families of programmable controllers. Allen-Bradley will manufacture these interface boards and install them in the DATA GENERAL/One portable com-

puters at its surface-mount manufacturing facility in Twinsburg, Ohio. The configuration of the final Allen-Bradley T45 product will include the interface boards, a liquid crystal display (LCD) screen, a 20 MB hard disk, and 1.5 MB of memory.

According to Jim Coburn, Allen-Bradley's Factored Products manager, Allen-Bradley recognized that changing industrial applications could accommodate non-factory-hardened, portable computers.

"Many of our customers have been able to reduce the harsh demands of their manufacturing environment," Jim says. "They no longer require the high degree of industrial hardening that we have provided in programming terminals for our traditional markets.

"In addition," he continues, "with several generations of programmable controllers installed, we looked to reduce customer costs by developing one 'universal' programming device on a standard hardware platform. This standard platform would also extend the function of the device beyond programming to areas such as diagnostics, simply by adding new software applications."

Ward MacKenzie, vice president of Corporate Marketing, says, "During the development of the DATA GENERAL/One Model 2T, Data General employees spent a great deal of time with Allen-Bradley engineers to ensure that the new portable would meet their expectations. This close cooperation has resulted in a portable terminal that will meet Allen-Bradley's high standards for function and durability."

Among the features of the DATA GENERAL/One Model 2T computer that Allen-Bradley engineers considered essential were speed and expansion card capability. The Model 2T features two 4-inch by 4-inch expansion slots that provide significantly more board space than comparable portables.

Jim adds, "Also important was the fact that the DATA GENERAL/One Model 2T contains both a serial and a parallel port for flexible peripheral connectivity while working with the programmable controllers. In fact, the Data General system was the only solution with this combination of flexibility and expandability.

Allen-Bradley Company, a subsidiary of Rockwell International, is the world's leading supplier of programmable logic controllers.

## Need Supplies? Go To The Stockroom

Nearly 3,000 employees work in the 2400, 3400 and 4400 Computer Drive facilities in Westboro. They rely, for the most part, on the Engineering and Office Supplies Stockroom in Building 14B to keep them outfitted with general supplies. The stockroom, located at Mail Stop E-221, stocks supplies such as pens, note pads, paper clips and tools. The facility is maintained by **Jeanne Bilodeau** and **Richard Rockel**. Jeanne is responsible for the office supplies, and Richard handles the engineering supplies. Both report to **Al Heck**, General Purchasing manager.

"Employees in Westboro now are able to request various supplies by sending an electronic message to us," Richard says. "We then print out the request, fill the order, and put it aside for the employees to pick up. Employees do need to have authorization in order to receive the supplies. At this time, more than 300 employees have the necessary authorization for office supplies, and 200 are authorized to order engineering supplies."

The stockroom operates every day from 8:00 a.m. until 4:30 p.m. The stockroom is closed on Wednesday mornings from 8:30 until 9:30 for a weekly staff meeting.

"We provide a service for employees. The stockroom is a great convenience," Al says. "This operation was started about two years ago. Previously, we did not have a centralized location for supplies. Now, we offer one location at which employees can get the supplies they need."

Employees are limited to \$100 a day when ordering office supplies. Space is limited, so the amount of supplies stored in the building is limited, as well. Jeanne and Richard carefully monitor the inventory to ensure that they are able to service employees.

"We know when new projects are being developed, for example, simply because the need for engineering supplies becomes greater," Richard continues. "There have been times when we have run out of a certain part that a developer needs. When that happens, we contact other stockrooms in Westbrook or Portsmouth,

or even Singapore. I have a list of nearly 50 people whom I can contact should an employee need a specific part we may not have."

Through on-line searching with other facilities, careful monitoring of inventory, and reports generated on a regular basis to get an idea of employee usage, Jeanne and Richard have dedicated themselves to serving employees as efficiently and quickly as possible.

## Copyright Notice To Users Of IRC

As many employees who use the Information Resource Center (IRC) already know, there are copyright laws which protect the rights of the software owner for the software and documentation that is available in the IRC. ### Employees **MAY**:

- use any of the software loaded on the hard disk drives in the IRC;
- use any of the software and documentation available through the IRC;
- request to borrow software and documentation for home use pursuant to the IRC's Loaner System; and
- order your own copy of the software and documentation.

### Employees **MAY NOT**:

- make copies of the software, documentation or any portion of that software or documentation without the express prior permission of an IRC staff member (note: permission is granted in very limited instances);
- distribute the software, documentation or any portion of it to others;
- install the software on machines other than those authorized by the IRC;
- alter, modify or adapt, in any way, the software or documentation; and
- authorize others to use or perform any other activity relating to the software, documentation or any portion of that software or documentation.

The IRC provides its resources and services as a convenience to all Data General employees. Any violation by an employee of the copyright laws or of Data General's obligations to third parties may jeopardize Data General's license agreements with third parties, subject you (or possibly Data General) to po-

tential liability, and/or necessitate further restrictions on your use of the software and documentation available through the IRC.

### **Elite Cleaners To Start Operations At Data General**

Starting April 13, Elite Cleaners, will offer drop-off/pick-up dry cleaning operations at Data General in Westboro. Services provided will include same-day (if required) and next-day delivery service for cleaning, shoe repair services, and garment alteration services. Elite will be located at Mail Stop B-111, which is along the corridor between the main cafeteria and Lobby A. Quality Cleaners also will continue to offer cleaning services in their present location.

### **Tax Forms Available**

- **CEO 3.0 User (Including CEOwrite) (OA302)** - This course is an interactive, intensive workshop which will acquaint participants with the CEOwrite word processor (features, terms and functions) under AOS/VS. This five-day class starts Monday, April 18.
