CEO Light For Small Offices

Data General has introduced CEO Light -- offering the mailing, filing and calendar functionality of CEO office automation software, but at substantially less system memory, disk space and cost. CEO Light is a streamlined version of CEO. The new software addresses the needs of small system users and value added resellers (VAR).

"CEO Light targets three emerging markets in today's workgroup, and departmental computing environments," says Chris Stone, manager of Office Software. "Those markets are customers with low-end ECLIPSE MV systems operating with limited memory, and disk capabilities; customers managing information systems of any size, where the primary application requires most of the system's resources, but where there is a strong need for electronic mail, filing, and calendar scheduling; and VARs who are looking to couple their value-added application with a functionally-rich OA package that requires minimum system management."

While meeting these market needs, CEO Light is also a step in the implementation of Data General's office automation strategy. "CEO Light lowers the entry price for office automation capability," says Christine Wallis, manager of OA Market Development. "This product is consistent with Data General's strategic direction, aimed at broadening the CEO product line, making CEO products more tailorable to the customer's specific needs, and providing the best OA functionality for PC and terminal users."

A major feature of CEO Light is its ability to tailor both the Main and Interrupt menus, allowing a user to add customer-specific applications, or pre-defined applications provided by Data General. For example, a legal department can add its time, and billing application, while a financial department can add Data General financial packages.

Because CEO Light requires less system and managerial resources, it costs less when compared to similar CEO configurations. For example, operating on the ECLIPSE MV/2000, CEO Light costs \$1,800, compared to \$5,360 for the CEO package.

CEO Light operates on the full range of ECLIPSE MV/Family processors, from the ECLIPSE MV/1400 to

the ECLIPSE MV/2000, provided that the processor meets disk and memory space requirements. CEO Light is compatible with the Data General Personal Computer Integration (DG/PC*I) communications platform, and CEO Connection 3.10 networking software. Additionally, CEO Light can be networked to CEO systems. A CEO Light customer also can easily migrate to CEO at such time that the additional functionality is needed, and the hardware support is available.

The basic CEO Light configuration is available with two optional word processing packages: CEOwrite, or WordPerfect word processing software.

CEO Light ranges in price from \$1,800 on the Data General ECLIPSE MV/1400 to \$28,000 on the ECLIPSE MV/2000-II.

Data General To Sell Singapore PCB Plant

Data General has agreed to sell its Singapore printed circuit board (PCB) fabrication plant and certain assets for about \$13 million. The facility will be purchased by a local management group backed by Prudential Asset Management Asia, a subsidiary of the Prudential Insurance Company of America.

Last July Data General announced plans to sell its PCB fabrication unit and to phase out its other manufacturing operations in Singapore by the end of the year. This is part of an on-going cost reduction program.

Data General will have a less-than 20 percent minority interest in the new venture. The company believes that when the sale is complete it will not have a material effect on its financial position.

Upon completion of the buy-out, expected early next month, the plant will be an independent manufacturer of PCBs for sale in the Far East, Europe and the U.S. Most of the plant's 280 employees have been offered employment by the new firm.

New Orleans Sales Office Copletes VAR Tour

The New Orleans Sales office recently completed a successful VAR Recruitment tour with the help of the Solutions Recruitment Development group in Westboro. During the two-week period, a series of six VAR Recruitment seminars were held in Destin, Florida, Mobile, Alabama, New Orleans, Baton Rouge and Shreveport, Louisiana, and Jackson, Mississippi. The Sales representatives involved with the seminars were: Jay Bonnanno, Gene Cooper, Mac Wampold, Tony Bailey and Buddy West. Their goal was to attract potential VARs to attend the seminars. The success of the tour was evident, with 39 companies attending the seminars. As a result, one new VAR has already contracted to purchase \$250,000 of Data General equipment and another company joined the new Agent Program. Under the new agent program VARs can sublicense their software. The New Orleans Sales office also has developed an extensive list of prospective customers.

The success of this road show was dependent upon outstanding efforts of the entire New Orleans Sales and Systems Engineering teams. Chester Plauche, Sales branch manager, and Tom Blackham, Systems Engineering branch manager, coordinated the energies of Sales representatives and systems engineers for each seminar. As a result, the seminars proceeded smoothly and equipment demonstrations worked perfectly. Discussing the merits of Data General and its equipment were: Chester, Preston Lawhorne, Eastern Operations Marketing manager, and Donna French, marketing specialist in Solutions Recruitment Development. The seminars also featured testimonials from successful VARs from each area including, Accu-tech Computer Services, Vitro Services, Computer-Source, Inc., Dataweld, Inc. and Systems Solutions, Inc.

More VAR recruitment seminars have been scheduled for the upcoming weeks. From October 12 through October 14, seminars will be held in Orlando, Tampa, and Jacksonville. On November 13, a seminar will be held in St. Louis, and on November 16 in Charlotte, North Carolina. Radio Club Sponsors Data Link

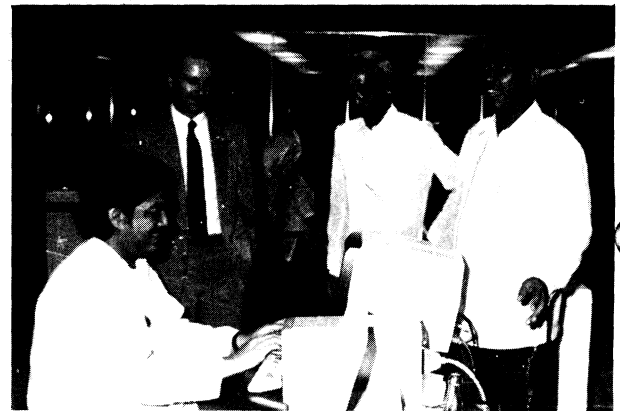
The Data General Amateur Radio Club (DGARC) has converted one of its two amateur radio voice repeaters for use as a full-time data link in a growing network of amateur radio operators ("hams") that communicate via TCP/IP, the same protocol that links thousands of academic, government and military computer installations throughout the country. The repeater link is the first of its kind in New England. Similar equipment

is used in other parts of the country to link the personal computers of amateurs for the purpose of sending electronic mail, transferring files and other services.

The repeater, with its antenna located on the Data General radio tower in Southboro, provides radio coverage extending west from Boston to Sturbridge and south from Nashua, New Hampshire, to Providence, Rhode Island. The repeater is expected to become a major part of the Amateur Packet Radio network (AMPR), an officially recognized packet transmission network. The network will eventually link amateur radio operators throughout the country and handle thousands of non-commercial messages via electronic mail daily.

COMET Announces New Modules

The COMET Program Team has been busy over the past several months, adding three new modules and enhancing two others. The new modules are Datapro Inquiry, the Field Engineering Services guide and NASD Policy/Procedures. The Automated Administrative Review (AAR) and COMET manuals have been enhanced.

COMET is an on-line system, designed to support the major components of the sales cycle. Available to all Data General Personnel, COMET's menu driven tools reside as an application of CEO.

Datapro Inquiry, the Field Engineering Services guide and NASD Policy/Procedures no longer need to rest as bulky manuals on employees' desks. All three modules are available on-line, in easy-to-use, menu driven formats and delivered to CEO in-boxes as word documents.

Datapro Inquiry gives employees immediate access to information on products offered by companies such as IBM, Digital Equipment, Hewlett-Packard, Prime and Wang. In addition to specific information on products for each competitor, Sales representatives have access to: corporate and financial profiles, distribution channels, corporate marketing strategies, applications directions, national account strategy, and support programs. It provides information that will help Sales representatives better understand their competition.

The Field Engineering Services guide contains detailed information on service forms and contracts, Field Engineering policies and procedures, all hardware and software services offered by Data General, and Field Engineering competitive analyses.

NASD Policies/Procedures contains the beginnings of an on-line COMET library that details the operating policies of all NASD functions.

The enhanced order entry module, AAR, allows employees to transmit quotes or order control numbers to Sales Administration and within minutes receive confirmed pricing and discount information. Now it is possible to present the customer with an all-encompassing quote, covering equipment and support services.

The COMET manual is a tutorial for all operators and newly-hired Sales representatives. Thanks to the enhancements, response time is quicker and it is now easier to access the contents. In general, it is easier for Sales representatives to reference all of the mechanics of this powerful tool.

Data General Captures The Governor's Award



Data General's float stole the show at the annual Colorado Springs Pikes Peak or Bust Rodeo Parade.

Data General's float entry in the annual Colorado Springs Pikes Peak Or Bust Rodeo Parade was awarded the Governor's trophy (first place in merit) at a parade held last month. The theme of this year's parade was the "Wild and Wacky West." Data General's float fit the category perfectly, with six "terminal head" people pulling a covered wagon. On the wagon a campfire scene was portrayed, with three cowboys sitting around a campfire. Only this campfire was a special effects fire, and the cowboys were serenaded by three DATA GENERAL/One computers, generating computer renditions of "She'll Be Coming Around The Mountain When She Comes" and "Skip To My Lou." In addition to the music, the DATA GENERAL/Ones ran a graphics software program, which displayed the parade's theme, followed by Data General's name and logo. The program also featured a drawing of the float itself, as the terminal heads pulled the float across a mountain backdrop.

The rodeo parade was an excellent way for Data General and its employees to interact with the community. The event, one of the largest in the state, has

been held every year since 1897. It is viewed by more than 100,000 people in addition to being aired live over local television. As a result of its award winning float, Data General dominated the evening's news programs.

Since central Massachusetts is no longer in area code 617, the phone system expects you to include these digits when dialing Eastern Massachusetts and other locales outside the 508 area.

Benefits

New Regulations On Taxation Of Group Life Insurance

Data General is now required to withhold Social Security (FICA) tax on the value of company-provided life insurance that exceeds \$50,000 less any contributions the employee makes toward the coverage. Data General provides employees with Basic Life Insurance equal to two times their salary, and employees may purchase Supplemental Life Insurance equal to one, two or three times their salary. All coverages combined may total up to \$300,000.

In the past, tax liability was limited to income taxes and Data General was only required to report the value to employees at year end. Recent legislation, however, states that the additional income is also subject to Social Security (FICA) tax which must be withheld before December 31 of each year.

To comply with the Internal Revenue Service (IRS) rules, Data General will: begin withholding FICA tax from the weekly or biweekly paychecks of affected employees beginning October 1, 1988; and calculate the FICA tax retroactive to January 1, 1988 and withhold that amount - evenly distributed - from the weekly or biweekly paychecks of affected employees during the month of October.

Employees who have reached the FICA wage maximum of \$45,000 for the year will not have additional FICA tax withheld.

The value on "imputed income" is calculated on the basis of a table published by the IRS that assigns a value to each \$1,000 of life insurance, and is directly related to the amount of insurance in force and to the age of the covered employee.

The following are estimates of what employees can expect to see withheld from their paychecks in Oc-

tober. Each of these estimates depends on the employees salary and total amount of life insurance in effect.

Age	Estimated Weekly FICA Withholding During October
Under 40	Little or no additional tax
40 - 44	between \$0.20 and \$3.20
45 - 49	between \$0.30 and \$9.00
50 - 54	between \$0.50 and \$17.00
55 - 59	between \$0.70 and \$29.00
60 and over	between \$1.00 and \$47.00

The regular weekly amount to be withheld beginning in November will be approximately one-tenth the amounts shown above.

Employees with a substantial tax liability for October will be notified in advance in order to prepare for the weekly deductions.

Beginning in January 1989, Data General will also withhold federal and state tax on imputed income. While not required, this process will eliminate a separate W2 at year end and the unexpected tax liability for some employees that results from large amounts of imputed income.

Maximum Contributions Increased For S&I Plan In 1988

Employees participating in Data General's Savings and Investment Plan are being given an opportunity to make additional pre-tax contributions to the plan during the final three months of calendar 1988. The \$5500 limit on annual contributions is being raised to \$6,000. This change does not affect any employee earning less than \$46,000 and even then may only affect employees who have been contributing a high percentage of their pay to the Savings and Investment Plan.

Data General allows contributions up to 12 percent of pay. An employee who has reached the \$5500 maximum and is still enrolled to contribute will have contributions resume in October and continue until the \$6000 maximum is reached. Any employee wishing to adjust contributions for the final three months of the year due to this change may do so by submitting an Enrollment form to the Benefits department by Friday, September 23.

On January 1, 1989, the annual maximum will return to \$5500 but may be raised later in the year. Data General sets a maximum contribution level below that allowed by the Internal Revenue Service (IRS) to assure that the plan meets requirements that prohibit discrimination in participation among different groups of employees. The increase in the maximum is allowed when IRS "tests" show that the plan will continue to be non-discriminatory even if additional contributions are allowed.

S&I Withdrawals Further Restricted In January 1989

The Data General Savings and Investment Plan normally provides for withdrawals only after age 59 1/2, at retirement, or upon termination. However, a few specific instances which are considered "hardships" allow withdrawals by paying a 10 percent tax penalty. The instances include purchase of a primary residence or payment of school tuition when no other funds are available.

Beginning in 1989, the amount allowed for hardship withdrawals will exclude earnings on or after January 1, 1989. For example, an employee with a \$5,000 balance at the end of December 1988 who makes no contributions in 1989 would be limited to a \$5,000 hardship withdrawal in the future even if the account had grown with earnings. Similarly, a person who continued to contribute would see the amount available for hardship withdrawal increase only by the actual contributions and not the earnings after January 1, 1988.

Employees using the Savings and Investment Plan for its primary purpose of saving for retirement should not be affected by this change. Employees anticipating hardship withdrawals for purchase of a home or to cover college tuition may wish to re-evaluate their contribution level as of January 1, 1989. Changes in contributions for January may be made up to mid-December.

Changes And Enrollments For S&I Plan Must Be Made By 9/23

Regular employees who have completed at least 90 days of service before October 1 are eligible to participate in the Data General Savings and Investment Plan. Those wishing to enroll must do so by September 23 by completing an enrollment form and returning it to the Benefits department.

Employees may also change contribution percentages, direct contributions to different funds, or transfer balances between funds (if no transfer has been made in the last six months) by completing a form by September 23.

- **RDOS Internal Structures (SM401)** - This course teaches the development of design guidelines for system-wide RDOS applications. This five-day seminar begins Monday, September 19.
- **The 32-Bit Language Environment: Concepts & Techniques for Programmers (SM507)** - This seminar details the run-time environment for 32-bit compiled languages that conform to the Virtual Storage/External Calling Sequence standard. This five-day seminar begins Monday, October 3.

Routes For Dasher Road Races

Today is the last day to enter the Dasher Road Races scheduled for Friday, September 16. Entry forms must be received at Mail Stop C-128 in Westboro by the end of today.

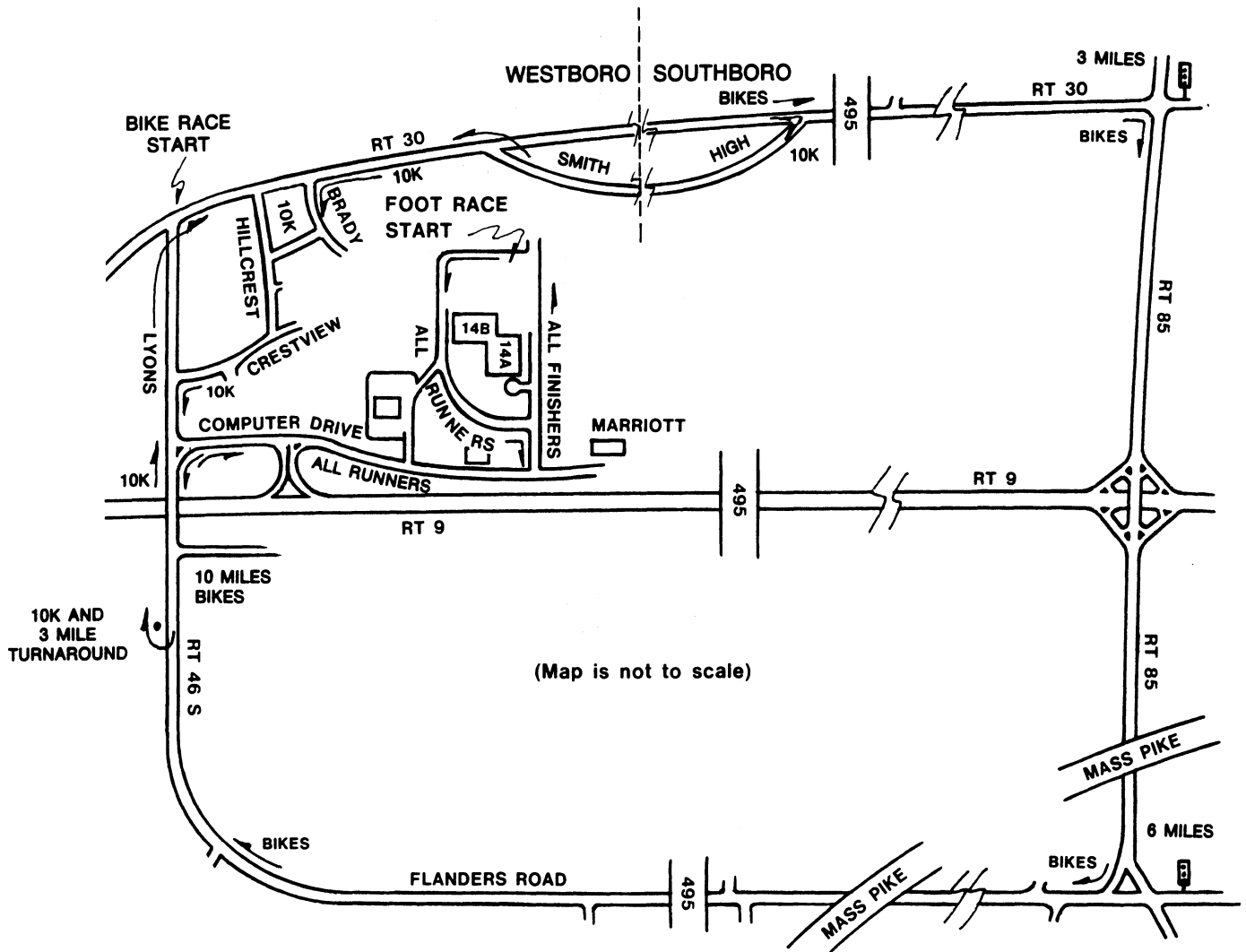
Included will be 3-mile and 10-kilometer foot races and an 11-mile bicycle race. Walkers are invited to participate in the 3-mile event. Bike race participants are required to wear hardshell helmets. Because of

the construction on Flanders Road, last spring's new 10K route will again be used instead of the traditional course. This new route is slightly short, about 300 yards shy of 10K. For the same reason, the new Dasher bicycle race format adopted last spring will again be used. Instead of the usual 15.5 mile road race there will be an 11-mile time trial. Details of the time trial format will be sent along with numbers and rules to all registrants.

Competitor numbers will be sent out several days before the race. Cyclists will have numbers 101-199; the 3-mile runners will wear numbers 301-599; and the 10-kilometer runners will race with numbers in the

601-699 series. Betsy Anderson, Race Committee chairperson, urges each participant to check the number assigned to him or her. "The assigned numbers are the only way we have to determine the results."

Here Are the Race Routes

The foot races will begin at 5:30 p.m. in the rear of Building 14A in Westboro in the east corner of the north parking lot (the usual starting line). All bicycle race entrants will gather at the old starting area at the back of the Data General parking lot at 5:05 p.m. and ride as a group to the new start on Lyons Street.

3-mile foot race: Start in the rear north parking lot and head off behind Buildings 14A and 14B, past the access road to 2400 Computer Drive, out the main driveway onto Computer Drive. At the end of Computer Drive, turn left (staying outside the traffic island and always on the right side of the road) and cross the bridge over Rt 9. Run down the hill to the turn-around point - there will be a course marshall standing there to show you where to turn. Go back up the hill, turn right onto Computer Drive, run up Computer Drive and turn left into the main Data General entrance. Run straight back to the rear of Building 14A and finish where the race began.

10K foot race: Follow the 3-mile route to the turn-around and turn around. Go back up the hill to the intersection at the end of Computer Drive (up until this point the course is identical to the 3-mile course). At the intersection continue straight ahead bypassing the Jersey barrier on Lyons Street around the right end. Continue down Lyons St. and turn right on Rt 30 at the end. Go east for 1-1/4 miles on Rt 30, then take a sharp right onto High St. Follow High St up over the hill and back down to Rt 30. Turn left and follow Rt 30 for 1/4 mile and turn left onto Brady St. Go 1/10 mile and bear right, and after another 1/10 mile turn left onto Hillcrest. Go up the hill and turn right on Crestview. Go 2/10 mile to the end of Crestview and turn left onto Lyons. Go past the Jersey barriers again and turn left on Computer Drive. Run the length of Computer Drive and turn left into the 4400 Computer Drive main driveway. Continue straight to the finish line behind the building where you started.

11 mile bicycle race: The start will be at the intersection of Lyons Street and Rt 30, NOT at the back of the Data General parking lot. From the start the route is the same as the old road course. Go east on Rt 30 3 miles to the traffic light at the intersection of Rt 85. Turn right and follow Rt 85 for 3 miles to Southville Rd. Turn right on "short cut" 100 yds before the traffic light at Southville. Go west 4 miles on Southville/Flanders road and up the hill over Rt 9 on the connector road. Turn right onto Computer Drive, go up the hill and turn left into the 4400 Computer Drive entrance. Ride to the regular finish line at the back of the Data General parking lot.

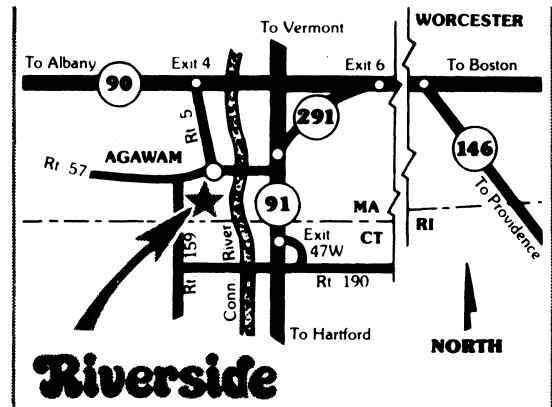

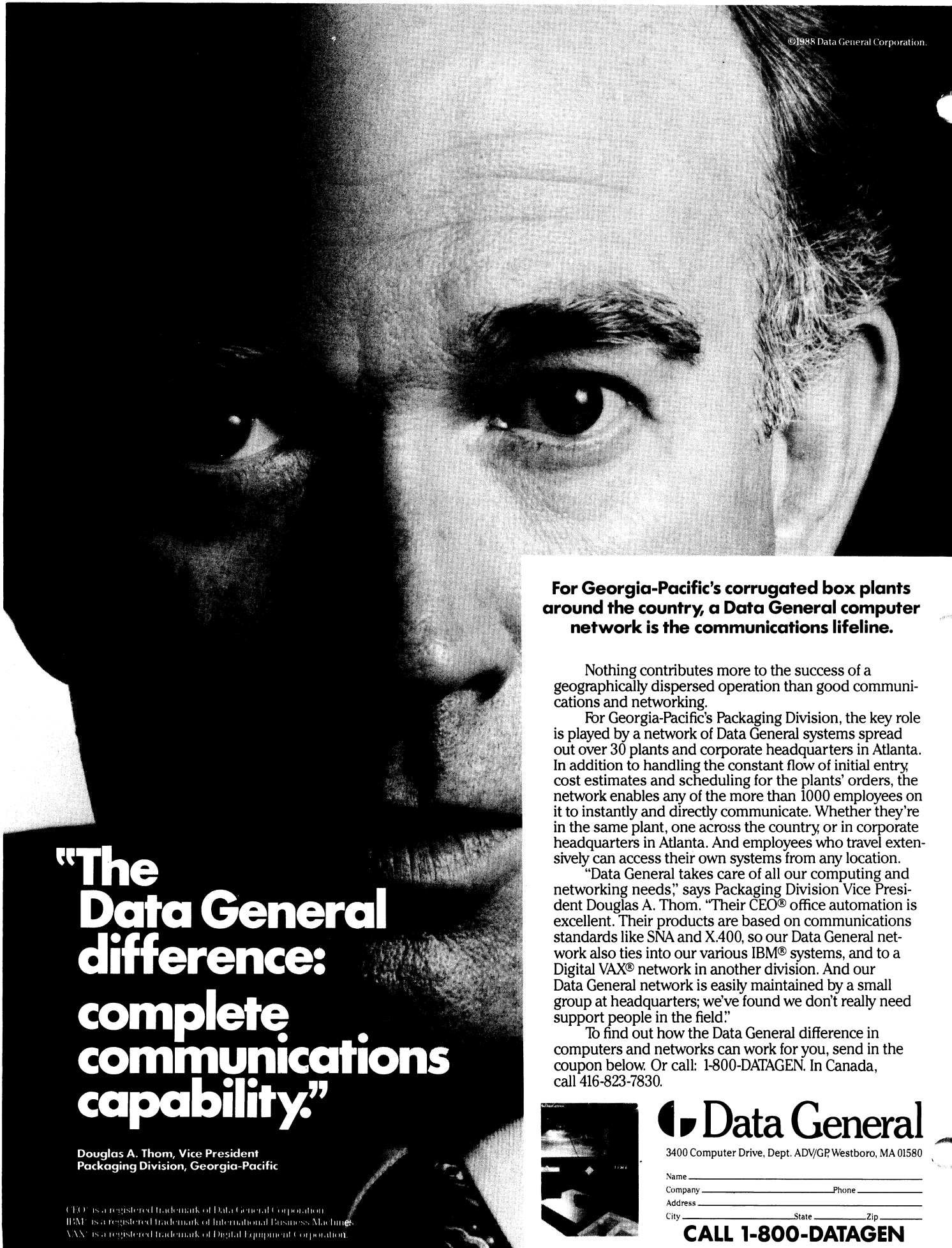
