### Stock Bought At \$27.00 New Period Price Is \$29.50

Employees who participated in the Data General Stock Purchase Program, which ended on January 30, 1987, purchased stock at **\$27.00**, 85 percent of the average market price on August 1, 1986, the first day of the plan.

Data General stock certificates will soon be mailed to participants' homes. Anyone who expects to receive stock but does not by **February 20**, should first contact Employee Shareholder Services to verify purchase, then contact Morgan Shareholder Services Trust Co. at (212) 277-6447 to find out if the certificate was returned to Morgan as undeliverable. Allow at least one week for certificate to be returned to Morgan.

For the February through July period, the opening day price was **\$29.50**, 85 percent of the average market price on February 2. Stock will be purchased at **\$29.50** or 85 percent of the average market price on July 31, 1987, whichever is lower.

For your information, the average fair market value on **January 30, 1987** was **\$33.125**.

### Amendments Approved At Annual Meeting

Data General stockholders recently approved all of the proposals listed in this year's Proxy Statement.

Ninety-nine percent of the stockholders voting elected the five directors of the company as set forth in the Proxy Statement. Those directors are Ed de Castro, Herb Richman, Fred Adler, Ferdinand Colloredo-Mansfield and John McArthur.

Also approved was the proposal which called for an amendment to the Restricted Stock Option Plan. It was approved by 64 percent of the voting stockholders. Approval of this amendment increases the number of shares of common stock that may be issued through the plan to 10 million from seven million.

A proposal which asked for an amendment to the Employee Incentive Stock Option Plan was approved by 71 percent of the stockholders voting. Approval of

this amendment increases the number of shares to four million from three million. Approval of the Restricted Stock Option Plan and the Employee Incentive Stock Option Plan amendments will help the company to attract and retain key employees.

Nearly 78 percent of the stockholders voting approved the proposal which addresses the Employee Qualified Stock Purchase Plan. This amendment will increase the number of shares available to employees to purchase at discounted prices to 3.6 million from 2.6 million. This increase will better enable employees, who might not otherwise be able to do so, to acquire stock in Data General.

Seventy-five percent of the voting stockholders approved the amendment to the Restated Certificate of Incorporation. This stockholders' vote eliminates the board of directors from personal liability for monetary damages resulting from certain stockholder complaints based on the judgement as to what is best for the company.

The amendment which allows the company to enter into Indemnity Agreements with its directors and officers was approved of by 75 percent of the voting stockholders. This amendment protects directors and officers against certain liabilities and expenses arising out of legal proceedings brought against them by shareholders. Both proposals will help attract and retain officers and directors, ensuring that the company is managed consistently.

### CEO Graphics Enhanced

Data General has enhanced CEO office automation software graphics by introducing DG/Fontstyles software and by integrating new business graphics capabilities with CEO Decision Base software.

With DG/Fontstyles software, an additional twelve presentation-quality typefaces may be used with existing Data General graphics software packages CEO Drawing Board, TRENDVIEW, and WORDVIEW. Users of the enhanced version of CEO Decision Base can create charts from spreadsheets or data tables with a single keystroke.

"With these enhancements, CEO users can add high-quality graphics to business presentations quickly and easily," says David Lyons, vice president of Group Marketing. "And since these packages are fully integrated with CEO office automation software, now more than ever, CEO is the best choice for business automation."

With enhanced CEO Decision Base, a single function key selects data from spreadsheets or data tables to create a chart which can be saved in the CEO filing system as GKM (Graphics Kernel Metafile) documents then edited using CEO Drawing Board. CEO Decision Base is integrated decision support software for spreadsheet, personal data base, and charting applications that now include bar, pie, line, x-y (scatter), and surface chart options.

DG/Fontstyles is designed for the Data General AOS/VS operating environment and supports six filled and six unfilled font styles as well as international character sets. The new package provides true graphics-arts-quality font capabilities licensed from Bitstream Inc., Cambridge, Massachusetts, a leading vendor of digitized fonts. DG/Fontstyles is a separate software package which can be bought to enhance the presentation quality of other Data General graphics software packages that are fully integrated with CEO office automation software including CEO Drawing Board, CEO WORDVIEW, TRENDVIEW.

CEO Drawing Board is an interactive, two-dimensional, graphics program that is fully integrated with the AOS/VS CEO environment and provides CEO users with freeform drawing and graphics editing capabilities using an icon-based menu interface. With CEO WORDVIEW, CEO word processing documents can be converted directly to a user-specified word chart format without manual re-typing to produce near-typeset-quality word charts. And TRENDVIEW graphics display software, when integrated with CEO PRESENT information presentation facility, can be used to create charts and line graphs from tabular data on a wide variety of monochrome and color Data General graphics display terminals.

## Ron Lincoln Named Director Of JBD

*Ron Lincoln* has been named director of the Japanese Business Development (JBD) group, responsible for overseeing business activities taking place between Data General and Nippon•Data General. Ron reports to Bob Miller, senior vice president of the Information Systems Group. Ron also serves as a member of Nippon•Data General's Board of Directors.

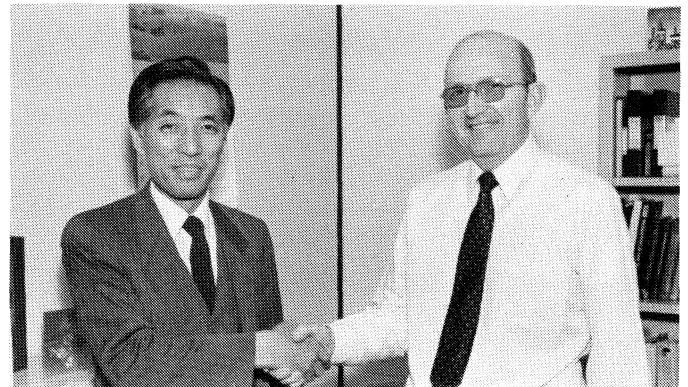

## "Focus On The Future" Comes To Milford

Nearly 600 Field Engineering employees from Westboro, Milford and Woodstock met in Milford last month to "Focus on the Future."

Reflecting on the meeting, Dick Camuso, Data General's senior vice president for Worldwide Field Engineering, says, "The "Focus on the Future" session allowed us to communicate Field Engineering's goals to everyone and discuss the direction of our business. Both Field Engineering and Data General as a whole have a great deal of positive things going for them. Through this meeting, we were able to clear up some old business and begin focusing on our future, which is bright."

In his remarks Dick stated that the success of the worldwide Field Engineering Division was evident in that for fiscal 1986 the division generated annual revenues for Data General of nearly \$400 million, which is almost as large as a company breaking into the Fortune 500. He attributed this success to all worldwide employees. Speaking on a broader term Dick pointed out that from the product line and organizational standpoints, Data General is strongly poised to remain a success in the computer industry.

Also speaking at the meeting were: Bill Bentley, vice president North American Engineering; Fred Cochrane, vice president of Engineering Services; Tony Nicoletti, vice president of Support Services; Larry Pitterman, Director of Human Resources and Ernie Hantavis, director of Finance. A question and answer session followed the presentations, covering business directions, organization, morale, compensation and work location.

Following the meeting was an open-house where employees had the opportunity to view Data General's latest "pieces of art" including the ECLIPSE MV/15000 computer. Also on display was an ECLIPSE MV/2000 computer, a DASHER/One computer, a DASHER 286 terminal, a Data General/One computer as well as Data General peripherals. The On Line Information Service (OIS) also was demonstrated to show how customers can receive software and hardware support via a computer. The session included videos of the Data General Team Tyrrell Formula 1 racing crew, and recent television advertisements on networking products.

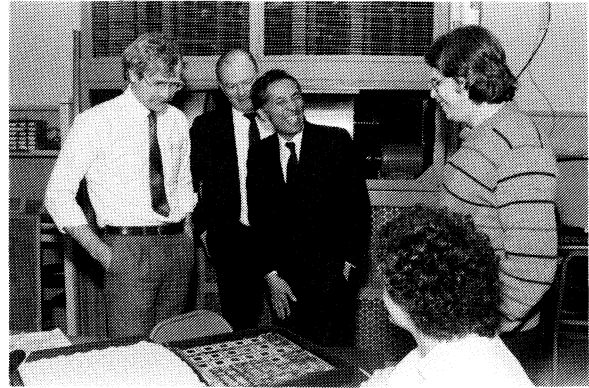

#### **W2s On The Way**

Data General employees required to file their earnings with the U.S. Internal Revenue Service and/or state taxing agencies may have received as many as five separate W2 forms for 1986. These forms may be:

- 1986 Earnings Statement
- Car Allowance
- Group Insurance
- Stock Option
- Relocation

### **W2s For Life Insurance**

Many Data General employees recently received W-2 statements for their Data General group life insurance. In accordance with IRS regulations, any life insurance in excess of \$50,000 provided under a group plan is considered taxable income. The amount of the "imputed income" is calculated on the basis of a table established by the IRS. It is directly related to the amount of insurance in force and to the age of the covered employee. Any contributions you have made toward the cost of the coverage have been deducted from the income shown on your W-2

The amount reported on the W-2 is additional taxable income which must be reported on your 1986 income tax return. Any questions pertaining to these W-2 statements should be directed to Payroll:FIN7.

### **Tax Forms Available**

Starting Monday, individual federal and state (Massachusetts) income tax forms will be available in the literature rack outside the Westboro pizzeria. Availability is limited, so employees should take no more than two of each and only those that are needed. Forms that do not appear in the rack should be obtained through the Internal Revenue Service, a bank or other public distribution location. Employees should not contact the Corporate Tax department for forms or assistance.

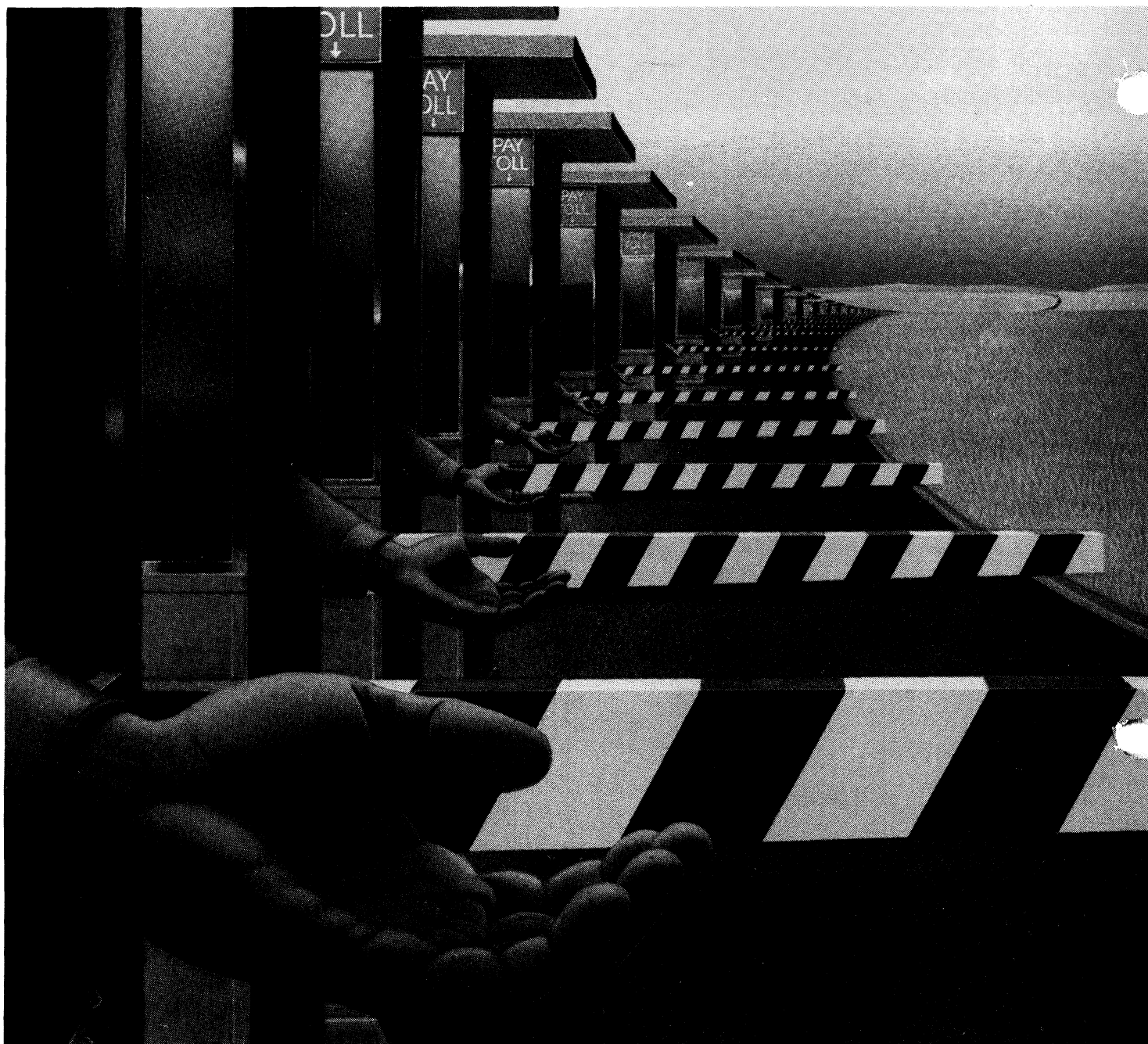

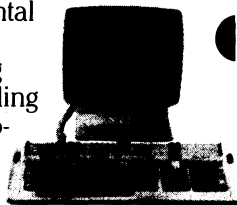
