### Data General Signs Contract With OCLC

Data General has signed a new three-year contract with Online Computer Library Center (OCLC) for Data General ECLIPSE MV/Family computer systems and upgrades. A separate Field Engineering services contract was previously signed in May 1987. OCLC and Data General estimate that these contracts will exceed \$20 million over the next three years. OCLC's library automation software operates on the full line of Data General ECLIPSE MV/Family 16- and 32-bit minicomputers.

OCLC's LS/2000 System is a turnkey approach to local library automation, including highly specialized functions such as Online Search Catalog, circulation, file, bibliographic, administrative and serials control.

Ken Harris, OCLC senior vice president of Marketing and Field Operations, says "Data General has responded very positively to our unique local systems needs as well as providing strong marketplace sales support, field engineering and corporate resources. They have helped us become more responsive to our users' needs."

Ward MacKenzie, vice president of Corporate Marketing, says "Data General's relationship with OCLC demonstrates our commitment to VAR needs in the reseller market. Working with OCLC, we can combine our technological leadership with expert applications to develop the most competitive industry-specific solutions for library automation."

Based in Dublin, Ohio, OCLC is a non-profit membership organization providing computer library service and research. A Data General value-added reseller since 1982, OCLC also is a large CEO user, with more than 350 CEO users networked across three ECLIPSE MV/20000 systems at their corporate headquarters. OCLC has more than 150 Data General installations nationwide and in the United Kingdom at medical, university, government, public and corporate libraries.

### CEO Travel Reservations Are Now Available

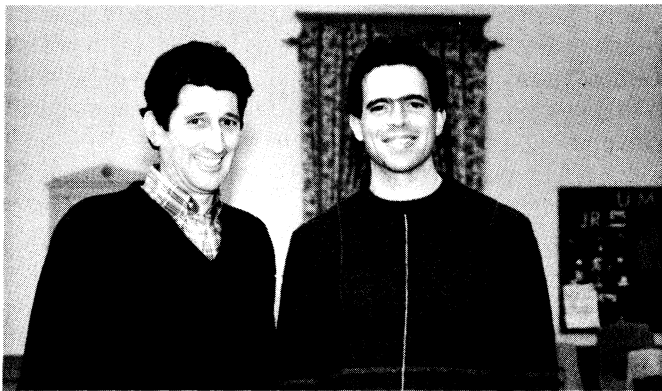
Employees within the Corporate Travel Services now can provide you with a trouble-free way to make business travel arrangements. Rather than pick up the telephone for your next travel reservation, send a request to the Corporate Travel Reservations office via CEO.

Corporate Travel Reservation employees check CEO business travel requests every 10 to 15 minutes and respond to urgent travel requests (for example, travel to take place within two days) in less than two hours. Less-urgent travel requests are answered within 24 hours.

The group has created a simple fill-in-the-blank CEO travel form that employees can file and copy each time they want to request travel services. To receive a CEO travel request form, send a message to **ADM Travel at host system IMG006**.

## Employees Perform With Local Theatre



*Data General employees Herb Fox and Chris Rice will be performing next week with the Sudbury Savoyards in the musical production "Utopia, Limited."*

Herb Fox, manager of the DG/Direct group, and Chris Rice, a staff writer within the Systems Development Division, will both be performing next week with The Sudbury Savoyards in this year's production of "Utopia, Limited," a comic opera written by Gilbert and Sullivan. Herb will be singing his third lead role with the group, having performed in "The Mikado" and "Iolanthe" the past two years. Herb says he answered an ad for lead auditions in 1985, and has been performing ever since. Chris recently joined the group, and is performing for the first time. The Sudbury Savoyards, an all-volunteer group, again will be donating the proceeds of "Utopia, Limited" to the relief of world and regional hunger.

The Sudbury Savoyards have been producing Gilbert and Sullivan operettas each year since 1961. The group recruits leads and chorus members from a wide area of eastern New England. Many of the cast and stage crew members also work in high-technology companies in the area such as Data General. The show is accompanied by a full orchestra, as well.

According to Chris, "Utopia, Limited" is a rarely-produced show. It is a classic satire, he says, of Victorian England.

"I was involved with the theatre in college, and wanted to get involved again," Chris says. "A friend of mine told me about this group, and I decided to sign up for this year's production. It is very exciting to work with more than 70 people for three months, rehearsing every week. It is satisfying, as well, to see the whole picture come together at the end, and see how our parts fit into that complete picture. The fact that our efforts support a charitable cause makes it even more worthwhile."

The production will take place at the Lincoln-Sudbury Regional High School Auditorium. Performance dates are Thursday, March 24, at 8:15 p.m. (tickets are \$3); Friday, March 25, at 8:15 p.m. (\$6 for adults, \$4 senior citizens and students); Saturday, March 26, at 2:30 p.m. (\$3 all seats), and 8:15 p.m. (tickets are \$6 for adults, \$4 senior citizens and students.)

## Tuition Reimbursement Tax Reminder

Data General has begun withholding federal, state and FICA tax from Educational Assistance reimbursements determined to be taxable under the law. A Determination of Tax Status form is now required of all employees requesting initial approval for a course and those already enrolled at the time they request reimbursement.

Generally, courses are **TAXABLE** when required to meet the minimum requirements for the current job or are part of a program that will qualify the individual for a new trade, profession or job.

Courses "required to meet the minimum requirements" would seldom apply to persons newly hired at Data General but may apply to current employees promoted into positions with a career plan to complete certain educational requirements.

A "program of study that will qualify for a new trade, profession or job" can be something very specific such as a program to become a lawyer or less specific such as a bachelor's degree in a particular field. Most bachelor degree programs qualify the individual for a new profession.

The reimbursement is **NON-TAXABLE** if the educational program or course is solely for the purpose of maintaining or improving skills of the individual required in his or her current job or in meeting the express requirements the company or law imposes as a condition to retain the individual's salary, status or job such as an engineering license or nursing certification.

Corporate Sales and Systems Orientation (CSSO) is a two-week course designed to introduce newly-hired experienced Sales Representatives and Systems Engineers to Data General's marketing strategies, hardware and software products, service and support organizations and industry competitors. The training course is held each month in the Training Center in Woodstock. Recently, nearly 50 employees from worldwide locations completed the course.
